




Financial Failure/Insolvency Claim Form

- 4 If your Section 75 claim is unsuccessful, please provide us with your credit card company's letter of declinature
- **5** Copy of a utility bill, for identification purposes
- 6 Any other documentation or receipts that you feel will support your claim
